3. Clerk's Report on Matters Arising from the Minutes

a) Bypass drains – now clogged with straw from lorries carrying from Fulbeck Airfield through to Sleaford. Chairman to take photographs to be forwarded with strong letter to Highways and LCC Councillors recording Leadenham Parish Council's extreme concern regarding the hazards caused during heavy rainfall due to drainage system no longer working efficiently and as designed.
b) Fountain – needs to be made safe. Sources to be pursued.

c) Shed on Long Lane (Brauncewell Lane) still not removed. Clerk to follow up.

d) KontakEnergie letter regarding Leadenham parish Council's involvement in administration of Community Finds should the project go ahead –Chairman to speak to the Company directly.
e) St Anne's Well – recent visit by Highway's Officer reported that they are looking at a long term solution to the drainage there. It is booked to be cleared again. There is a problem of how to dispose of the rubbish removed. To be kept clear regularly could become a DIY job for the community in the longer term.

f) Defibrillator at Bowls Club – ongoing

g) Station Yard – some further clearance of small trees undertaken. No residential evidence.

h) War Memorial – ongoing

j) Salt Bin on Newark Hill – reported as smashed. New Bin to be installed.
