Notes from the Meeting of the above Council held on Tuesday 12th April 2016 at 7.30 pm in the Village Hall.

2. Consideration and signing of the Minutes of the Previous Meeting

Mr G McLusky proposed that they be a true record of the meeting. Mr S Locking seconded the proposal. There were no objections. The chairman signed the Minutes.

3. Consideration of the Clerk's Report on Matters Arising from the Minutes

- **a)** Bowls Club barrier Mr Walker has indicated that he was awaiting the go ahead from the Bowls Club regarding installation of the car parking barrier. Parish Council and Village Hall Committee are still in agreement that the cost should be split three ways. Bowls Club to be informed of those decisions.

Ms M Nelstrop seconded the proposal. There were no objections. Two additional dog bins will be ordered.

6. Police Report

PCSO Sarah Kennedy reported no crimes within the parish during the previous month. There were no further reports.

Ms L Conway reported the progress of Devolution for Lincolnshire and on the success of an application by NKDC to the Heritage Lottery for renovation and development of Mrs Smith's Cottage in Navenby. The Report in full is available on the website.

9. Consideration and action on Speed Awareness throughout the village

Mr McLusky reported on a meeting with the Road Safety Partnership. Lamp posts were identified and a report will be forwarded to LCC Lighting Dept for permission to place additional speed awareness signs appropriately – with a one off payment of £40.

10. Update on grant applications regarding the War Memorial and the Fountain Mr O'Brien forwarded his report regarding the War Memorial as follows:

'I was contacted by the War Memorial Trust regarding our pre-application and details were discussed. The representative suggested that the 'later addition panels' could possibly be removed and the original names restored. A meeting is to be held within the week where the application will be discussed in detail. If the response is positive then a full application can be mad, with estimates, regarding funding'.

Mrs C Stokes reported all matters regarding a funding application for the Fountain are ongoing.

11. Play Area – urgent need to press forward with maintenance works.

An onsite meeting of Councillors was set for Tuesday 19th April at 2 pm to consider the quotes received regarding all items and decide which items to demolish and replace in due time and which to restore.

12. Annual Parish Meeting - finalisation of date and format of meeting Tuesday May 17^{th} was agreed with a short normal PC meeting from 7 pm - 7.30 pm. It was agreed to leaflet all houses within the parish regarding the date and thus encourage attendance.
