9. Consideration of Pre-Budget matters including quotations received to date in preparation for the setting of Precept 2017/18

10. Leadenham Bowls Club

Letter has been forwarded from the Bowls Club having agreed to a contribution payment for the barrier to protect the rear wall of the Pavilion from vehicle damage while parking. They expressed the wish that the Club and the Parish Council could look forward to working together for the benefit of all in the future.

Councillors agreed the time was now right to press ahead with putting a contract together for both partied to agree terms regarding ownership and responsibilities regarding the Bowls Club and Green – for the benefit of future Councillors and Committee members.

11. Matters for Urgent Discussion

a) Rubbish – Sleaford Hill – over the bridge on left – black bag and assorted rubbish. To be reported.

b) Hedge surrounding property beyond the bridge over A17 bypass (en route to Fulbeck) is overgrowing footpath – evidence of pedestrians constantly moving off the tarmac footpath onto the grass verge to pass by. Property to be contacted.

c) Speed Watch signs – on following up no response from Road Safety Partnership regarding our application along with a cheque in payment – it emerged that a survey by Street Lighting dept (LCC) had not been undertaken. The application will be resubmitted.
