
## **Public Assurance Meetings**

Did you know there are Public Assurance Meetings that support the Police and Crime Commissioner to meet his statutory responsibility to hold the Chief Constable to account? The meetings focus on the performance of Lincolnshire Police and provide assurance regarding the effectiveness and efficiency of policing services.

You can have your say too! As a member of the public you can submit one written question to each Public Assurance Meeting, regarding the performance of Lincolnshire Police. The question must be submitted no later than midday, five clear working days before the scheduled meeting.
