There is NO need to register for this scheme or supply bank details, energy suppliers will automatically apply the discount to the bills.

Action fraud is also warning about a sharp rise in reports relating to false emails purporting to be from Ofgem, the independent regulator for Great Britain.

The emails claim the recipient is due to a rebate payment as part of. Government scheme and provides links for the recipient to follow in order to apply for the rebate. The links in the emails lead to malicious websites designed to steal personal and financial information.

All the emails display the subject header "Claim your rebate bill now". Offenders are using the Ofgem brand logo to make the email to look as authentic as possible. However, the emails ask recipients to "apply for an energy bill rebate before September 2020" which is what prompted many recipients to realise the emails weren't genuine.

HOW YOU CAN PROTECT YOURSELF AND OTHERS

If you have any doubt about a message, contact the organisation directly. Don't use the numbers or address on the m,ESS age - use the details from their official website. Remember, if your bank (or any other official source) will never ask you to supply personal information via email.

If you have received an email which you're not quite sure about, forward to report@phishing.gov.Uk

Send them emails that feel suspicious, even if you are not certain that they are a scam- they will check.
