TRIBUTE FLOWERS PLANTED AT MRS SMITHS COTTAGE

A number of plants left in tribute to Her Majesty Queen Elizabeth 11 at Sleaford Market Place during mourning after her death have now been planted at Mrs Smith's Cottage in Navenby. They have been incorporated into the garden for them to live on as an enduring reminder of her life and service, in the setting of the cottage where they can be watered and cared for.

Some of the plants are being nurtured over the winter in a local volunteer's garden. The team are also in the process of getting a more permanent plaque to be fitted.

The cottage is open on Friday, Saturday, Sunday and Monday of each week.

RURAL ENGLAND PROSPERITY FUND OVERVIEW

In September the Government announced the Rural England Prosperity Fund, a £110 million pound scheme aimed at boosting rural economies as part of the levelling up agenda. North Kesteven has been allocated £747,556 to be used in line with th Rural Fund's aims, and so the Council is proposing a range of capital grant schemes that include:

Support for small rural businesses, large capital projects and for the wider economy in the District. A grant scheme that will support communities and community groups aiming to make an investment in projects that will benefit the community or contribute to the District reaching net zero.

The aim of the Rural Fund is to support capital projects for small businesses and community infrastructure, to improve productivity and strengthen the rural economy and rural communities. The two key priorities of the Rural Fund are focused on supporting rural, small businesses and entrepreneurs to either start-up, scale up or expand and helping rural communities to enhance digital infrastructure, community infrastructure and local green spaces and community led projects.

In order to qualify for the funding, the Council will need to submit an addendum to NK's already submitted UKSPF Investment plan for consideration by the Government, with a decision anticipated in January 2023.

Only limited guidance has been released by the Government to date but more details will be forthcoming.

WARM HOPME DOSCOUNT SCHEME

On 14th November the Department for Business, Energy and Industrial Strategy announced the reopening of the Warm Home Discount Scheme which will provide a discount of £150 off electricity bills for three million low income households this winter. Most households will receive the discount automatically.

The government has launched a new tool, to make it easier for the public to check if they are eligible for the discount. The online tool will guide customers through the eligibility criteria in England and Wales, asking questions about electricity supply, the benefits they receive and characteristics of their property.

All customers will receive a letter this month (November) and mid January 2023 confirming their eligibility and the payment will be made automatically through energy suppliers by March 2023. The government is also writing to customers who may be eligible, advising them to use the tool linked below to check eligibility, as well as to use the helpline for particular complex cases.
