Dear Ed Miliband,

Solar on roofs, not farmland STOP the Navenby Sub-station.

Impacts of current proposals on farmland

- Poor choice of sites, far from where the electricity is needed
- Loss of good farmland, locked up for 40 to 60 years our lifetimes
- Lose opportunity for food, energy crops, woodland, water
- Industrialising our countryside with glass, steel and concrete
- Tying us all into expensive, long-term foreign contracts on fastoutdated technology, bleeding funds out of the UK. Panels imported and built using coal-fired power, adding to our emissions by 2030.
- Years of disruption during construction, replacement, repairs, and decommissioning
- Risk of fire and toxic fumes from huge battery developments
- Impact on tourism and house prices and local economy, long term
- Little or no local benefit nor cheap electricity due to global control

Better energy options already exist. The benefits do not begin to justify the industrialisation of our beautiful rural *landscape*.

If all the proposals for solar went ahead, we would be well oversupplied. Solar on farmland will soon be outclassed by offshore wind and flexible solar panels as thin as cloth. Lincolnshire with the best farmland, already suffers plans to lock up areas the size of cities, 100 sq km of industrial development in our countryside - while better options, are ignored.

Instead there are 2,500 sq. km of commercial roof, lying vacant, enough for 2/3 of your requirement, plus a third from private roofs, car parks and other built structures. Companies will even add these for free, using light, modern materials.

Please stop this headlong rush to lock up and hand over our farmland to global investors for our lifetimes, with expensive long-term contracts we can ill afford. Please shift to using current built structures and keep our farmland British.
